

Daycare and Boarding Agreement and Policies

- I understand that I place my pet(s) under the care of Wag Central for boarding, daycare, or any other services without liability on the part of Wag Central and its staff for loss or damage from a disease, escape, injury, theft, fire, death, or other unavoidable causes, due diligence and care having been exercised. Wag Central and its staff will not be held liable for injury or damage to persons, other pets or property caused by pets in its care.
- While all pets participating in daycare or boarding at Wag Central are up-to-date on vaccinations, there are viruses with different strains that cannot be fully vaccinated against. Kennel Cough, and other ailments can be contracted at any time a dog comes into contact with another dog. I will not hold Wag Central and its staff liable for the contraction of any such illnesses during my pet's stay.
- I authorize Wag Central and its staff to allow my pet(s) to interact with other pets at the facility. I understand that, although all pets are evaluated for temperament and personality and playtimes are supervised by Wag Central staff, my pet(s) may become injured during interaction and play with other pets. I agree to hold Wag Central and its staff harmless for damages resulting from such injury.
- I authorize Wag Central staff to potty and take my dog out with other dogs, within the immediate property and surrounding premises of Wag Central. I understand that my pet will be kept on a leash using a slip lead or regular leash attached to a collar approved by both myself and Wag Central staff. I release Wag Central and its staff from liability for any damages caused by persons, their collars, stray animals, or forces of natures encountered in such time spent outside.
- If I request that more than one pet share a kennel, stay in the community room or luxury suite, I assume all responsibility for any injuries or illness they cause one another. I authorize Wag Central and its staff to place each dog in a different sleeping room, suitable for the health and safety of each dog should this situation arise.
- All pets staying at Wag Central's daycare or boarding facility will be checked for flea and/or tick infestation. I understand that if fleas or ticks are found on my pet, they will be given a flea bath or tick extraction at my expense. While every effort is made to maintain a flea/tick free environment, I will not hold Wag Central and its staff liable for the occasional occurrence of fleas or ticks.

Should my pet require medical attention for illness or injury while in the care of Wag Central and its staff, I authorize Wag Central to provide emergency medical care and to transport my pet to a licensed veterinarian of its choosing for treatment. I agree to reimburse Wag Central upon pick up of my pet for any costs incurred in such an event. While Wag Central and its staff will make every effort to secure necessary veterinary care in an emergency, I will not hold Wag Central and its staff liable if unforeseen circumstances make it impossible for them to do so.

If I leave a toy or personal item with my pet while boarding, I understand that the item may not be returned to me in the same condition as when it was left behind. I will not hold Wag Central or its staff responsible for damage to such items.

I understand that while the staff at Wag Central will do their best to keep any dogs with food allergies from consuming any food(s) that they may be allergic to, there are circumstances out of Wag Central's control (food dropped on floor, etc) that may result in an allergic dog consuming a food they have an allergy to. I also understand that Wag Central cannot guarantee any bakery items sold at the Wagaloo Cafe are 100% allergen free, as all treats are prepared on a shared surface.

I authorize Wag Central to charge outstanding late fees, cancellation fees, and other expenses incurred.

I hereby certify that I am the lawful owner of the pet(s) referenced in this application.
